Dear Parent/Guardian of Upcoming Kindergarten Student:

Welcome to the Haviland Avenue School. **We are excited to be offering full day Kindergarten sessions starting in September, 2015.** Parents/Guardians of students, including those currently enrolled in the SHAPE preschool program, must register in person for Kindergarten. Children entering Kindergarten must be five years old on or before October 1, 2015. Registration for children entering Kindergarten in the Audubon Public Schools for the 2015-2016 school year will be held in the Haviland Avenue School Media Center on the following dates:

Wednesday, February 25, 2015

(Last initial A to L)

9:00 A.M. to 11:00 A.M.

12:30 P.M. to 2:30 P.M.

Thursday, February 26, 2015

(Last initial M to Z)

9:00 A.M. to 11:00 A.M.

12:30 P.M. to 2:30 P.M.

Physical examinations are required for all new Kindergarten students before entering school. This exam must be recorded on a school form, which is included in our Kindergarten Registration Packet found on our website at <http://audubonschools.org>. The packet will also be available at registration or can be picked up in advance from Haviland Avenue School's Main Office or Meg Murray, District Registrar, who may be reached at the Audubon High School at (856) 547-7695, Ext. 4161. The Kindergarten Registration Packet is intended to give parents the option of completing necessary paperwork in advance of the registration dates. However, parents must still return the packet to the registration on either Wednesday, February 25, 2015 or Thursday, February 26, 2015, along with the following requirements:

- 1. Original Birth Certificate**
- 2. Two Proofs of Residency (1 Primary and 1 Secondary)**

Primary (must submit 1 of the following):

- Lease Agreement (must have CURRENT DATE)
- Property Mortgage Bill
- Property Tax Bill
- Property Deed

Secondary (must submit 1 of the following – bills not listed will NOT be accepted):

- Recent Utility Bill (less than 60 days)
 - electric
 - gas
 - water and sewer
 - cable

- 3. Proof of the following vaccinations, as required by New Jersey Law:**

DPT - a minimum of four doses with one dose administered on or after the fourth birthday or any 5 doses.

Polio - a minimum of three doses provided one dose is given on or after the fourth birthday or any 4 doses.

Measles - two doses vaccine with the first dose given on or after the first birthday.

Mumps - administered on or after the first birthday.

Rubella - administered on or after the first birthday.

Varicella - administered on or after the first birthday.

Hepatitis - three doses vaccine.

At the time of registration, this packet and supporting documentation will be reviewed. If you are missing any requirements, you will be informed at that time. Registration is considered incomplete until all requirements are met. Your child will not be assigned to a teacher/class or be permitted to start school until all documents are received.

Other information, including dates for Kindergarten readiness testing, our looping program, and Kindergarten orientation will be presented at registration.
